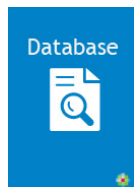

- Searchable content from journal articles, books, videos, images, reports, procedures, blogs, audio recordings, systematic reviews, and more
- Full-text indexing of all Lippincott Williams & Wilkins (LWW) content
- Search results organized automatically into customizable subjects
- Instant access to original content (via an openURL link resolver if necessary).
- Pre-selected content sets, publishers, or platforms to be included in a search.
- User customizations: saved searches, bookmarks, Alerts, and more.
- Usage statistics available in real time, daily, and weekly.
